

SHRINE MEMBERSHIP PROCEDURES

CANDIDATE FORM REQUIRED: Petition for Initiation and Membership

Pre-Requisite Requirements: Member of Blue Lodge in Good Standing. Is not/has never been an Alee or any other Shrine member. Recommended by two Alee Shrine Members in Good Standing.

ASSOCIATED MEMBER FORM REQUIRED: Petition for Association

Pre-Requisite Requirements: Proof of Membership in Blue Lodge. Proof of current membership in Good Standing at a Shrine other than Alee. Recommended by Two Alee Shrine Members in Good Standing. Payment amount of current year Temple dues amount. Exempt for Hospital and Per Capita fees. Members are responsible for membership dues at both Shrines but only need to pay the Hospital and Per Capita fees to their home Temple to remain Active & in Good Standing.

AFFILIATED MEMBER FORM REQUIRED: Petition for Affiliation

Pre-Requisite Requirements: Proof of current Membership in Blue Lodge. Current year membership fee. Was an Alee or any other Shrine member in the past and left in Good Standing. Must have a copy of Demit Certificate issued from the Shrine that you previously were a member. Recommend by two Alee Shrine Members in Good Standing.

DEMITTED MEMBER Written letter to Recorder stating member's wish to be removed from membership. Include name, date, membership number, current year dues/fees payment & signature.

Pre-Requisite Requirements: Must be in Good Standing for the current dues year; All dues, fees, etc owed to Alee Shrine must be paid before a member can demit in Good Standing. Once the member is in Good Standing, the Demit Certificate will be forwarded to them.

SUSPENDED MEMBER Suspension occurs when a member is not in Good Standing for the current dues year.

Current Year Dues are always due on or before January First (1st) of that year. (ie. 2016 Dues are due by January 1st, 2016) Members who do not hold a Shrine membership card for the current year cannot attend Shrine Stated Meetings, join nor participate in any Shrine Clubs &/or Units, nor participate in Shrine events, parades, fundraisers, etc. All dues, fees, etc owed to Alee Shrine must be paid before a member can apply for Restoration of Membership. During the year, at least two (2) Dues notices and a Notice of Suspension are printed and mailed automatically to those members who are not paid for the current year. To be reinstated, see Restored Member.

PRE-BODY REQUISITE SUSPENSION If a member of the Alee Shrine is Suspended from their Blue Lodge, they automatically become Suspended from Alee Shrine.

Pre-Requisite Requirements: A Suspended member must be reinstated in Good Standing as a Blue Lodge member before that member can apply for Restoration at any Shrine.

RESTORED MEMBER FORM REQUIRED: Petition for Restoration

Pre-Requisite Requirements: Proof of current year Membership in Blue Lodge. Payment of current year's dues. Was suspended from Alee or another Temple. Recommended by an Alee Shrine Members in Good Standing.
